JR – 15 or under and YR – 16 to 21. *New membership proposed for non-competing membership reduced to \$25. that would not be GMO. * Discussion beginning on splitting AA division by age. New addition would be 55 and older. * Adult Program Committee: ( Region 2 has a vacant position). Grants up to \$1000. to supplement educational events. This could be reduced as it is not being used. * The USDF Library – USDF etrak has been redesigned into the educational library.
